Otter Tail County Presentation: Film Plastic Recycling Program, presented by Zach Fjestad, Assistant Director of OTC Solid Waste Dept.

- No longer partnering with Revolution Plastics
- 100 dumpsters first placed in 2016, didn't get enough plastic but left dumpsters in place
- Applied for grant to buy front load dumpster truck as did not have ability to empty front load dumpsters being used.
- 2021: recycled 450 tons of film plastic from farms, boat dealers, and greenhouses
- Will be receiving 50 additional dumpsters soon, there is a waiting list of approximately 20 locations
- Hired part-time (20 hrs/week) driver 6 months ago
