Department of Ag update:

- Verndale local advisory team, 3rd meeting coming up majority already doing BMPs
- Continuing to work on RCPP, what practices, payment rates, developing a screening tool to determine
 priority, other administrative. BWSR and Dept. of Ag have committed \$410,000 combined in cash for
 projects need to work out how to manage that, EOT SWCD may act as the fiscal agent providing
 funding back to the other SWCDs.
- Priority projects: wellhead protection areas, farm business management program

TSA Update: last meeting held two weeks ago

- Reviewed report from Houston Engineering estimated that TSA would need 2 engineers and 3 technicians to cover the area
- Looked at staff that have JAA within the 16 SWCDs, only 28% of the staff have job approval authority
- Split into two groups, north and south, to work together to pool resources. A few SWCDs have chosen to be on their own. EOT SWCD already has agreement in place with Becker and West Otter Tail. Others may choose to join.
