## OTTER TAIL WBIF C25-0116 (2.0)

**6-C25-0116-11;** Gretchen Larson c/o Adam Plummer; Candor Township, section 14; is requesting to amend the landowner's name on the contract to Vergas Ranch Properties LLC with final payment for their forest stewardship plan reissued to Vergas Ranch Properties LLC (the prior check will be voided). The total cost of the



project was \$2,000.00 with an approved payment of \$1,500.00 which is 75% of the total cost. Motion made by Terry Greenwaldt, second by Wayne Enger to approve. A vote was held, by roll call, and all members voted in favor of the motion. Opposed: none, motion carried.

Irrigation Scheduler Program: Discussion was held on the potential purchase of a Flow Meter.

Opposed: none, motion carried. Motion made by Terry Greenwaldt, second by Bruce Albright to approve the quote from Esser to install and new water cooler/water bottle filling station. This will replace the water delivery we currently have. A vote was held, by roll call, and all members voted in favor of the motion. Opposed: none, motion carried.
