I hereby consent and agree no to:

- a) On any act which shall interfere with the running or operation of Ridgeline Outfitters when such activities conform to the rules and regulation of the state of Arizona and/or New Mexico.
- b) Use any of Ridgeline Outfitters' equipment or facilities of services if I do not have the ability to use such facilities, equipment or services safely with out instructions until I have requested and received sufficient instruction to permit safe usage.
- c) Engage in any harmful conduct or willfully or negligently engage in any type of conduct which contributes to or causes injury to any person.

I also agree t pay for an damages caused to others (including attorneys' fees and costs) if they are injured or elect to participate in spite of the known and unknown risks.

RELEASE: In consideration of the services and/or property provided, I, for myself and any minor children for which I am the parent, legal guardian, or otherwise responsible, any heirs, person representatives, or assigns, doe hereby release Ridgeline Outfitters, LLC its principal, directors, officers, agents, employees, and volunteers from any liability and waive any claim for damages arising from any cause whosoever (except that which is gross negligence). I further agree to reimburse you for all attorneys' fees and costs shoal I bring legal action again you and lose.
