BOOKING POLICY

A 50% deposit is required to book a hunt with Ridgeline Outfitters LLC. The balance is due 45 days prior to the hunt.

CANCELLATIONS

If for any reason you have to cancel your hunt, it must be done, in writing, 60 days prior to your hunt.
No cash refund will be given. Money will be applied to a future hunt.

STATE LICENSE

The cost for a New Mexico Non-Resident State License for quality Elk is \$773.00, standard Elk \$548.00, quality Deer \$368.00, standard Deer \$283.00, Antelope \$283.00. A \$9.00 Habitat Stamp is required on all licenses and a \$65.00 Game Hunting License. This cost is not included in our prices.

GENERAL INFORMATION

Hunters are responsible to transport themselves to and from our camps. Please make prior arrangements for this service. When in camp, we provide a full time cook on fully guided hunts. Meals include breakfast, lunch, snacks, and dinner. Lodging will consist of a house, cabin, or wall tent. Each hunter will have his/her own bed in the house or tent. Ridgeline Outfitters LLC hunts includes a professional licensed guide per two hunters. Two hunters per guide can be upgraded to one on one for an additional \$250.00 per day. The guide will be responsible for the field care of the trophy. **Landowner permits, licenses, and taxes are not included in the quoted hunt price.**

Ridgeline Outfitters LLC is not responsible for any changes in license fees, hunt dates, or any other changes made by New Mexico Game and Fish Department and Arizona Game and Fish Department.

If a hunter shoots and draws blood from an animal the hunt for that particular species is considered complete after 24 hours of searching for the wounded animal, even if the hunter does not retrieve the animal.

Gratuity for the guide is not included in price. Industry standard gratuity is 10% of the guide fees paid by the hunter. Taxidermy and meat processing is not included in price.

The hunter hereby agrees to hunt with Ridgeline Outfitters, LLC and use Ridgeline Outfitters, LLC exclusively for a guided hunt. Ridgeline Outfitter, LLC agrees to provide their outfitter identification number as part of services, to be used exclusively by Ridgeline Outfitters, LLC.
