This is a three-year contract for a total flat rate in the amount of \$7,200 (\$15/acre for 160 acres) in Wadena Township, section 2 and Aldrich Township, section 24, with the first-year payment of \$2,400.00. 2022-RE07; Nolte, Eric & Tim; requesting first year payment for cover crops. This is a three-year contract for a total flat rate in the amount of \$7,200 (\$15/acre for 160 acres) in North Germany Township, possible sections 4,5,8,9,10, with the first-year payment of \$2,400.00. NRCS District Conservationist's Report: Josh introduced Ivan Reinke as the new District Conservationist. The following report was given by Ivan. Currently making CSP & EQIP payments & certifications. Had one 2023 CSP renewal approved but they declined at the last minute. EQIP sign up ended on November 18, 2022. 21 applications were received for 2023. RCPP Irrigation sign up continues through December 16, 2022. A building accessibility compliance check was completed last week.

## County Commissioner's Report:

- 2022 negotiations are finished for Wadena County.
- Social services had a 26% budget increase from last year.
- Wadena County has a new resident recruitment campaign called "Wadena County is Calling" through the Economic Alliance.
- Thomastown Township vacated a road.

**Forestry Update:** LCCMR Grant is providing funding for three watersheds, including the Redeye. Our regular meeting was last week with Becker SWCD joining the SWCD Forestry Association. DNR is looking to purchase more cold storage for pulling more trees in the fall. BWSR and DNR are still working on their MOU.

- Motion made by Tom Schulz, second by Brett Dailey to nominate Ken Berg as a Policy Committee member for the Long Prairie Watershed, with Bruce Juntunen as an alternate in the event Ken is unable to attend.
  Opposed: none, motion carried.
- Motion made by Brett Dailey, second by Tom Schulz to approve the Implementation MOA for the Long Prairie Watershed. Opposed: none, motion carried.
